Each Cupboard is consistently stocked through the year with core school supplies, hygiene products, and healthy snacks. Hubbard's Cupboards directly benefits teachers and their students in need.

Sam and the Sam Hubbard Foundation staff spent time with the kids from the Larry & Rhonda Sheakley Boys & Girls Club, playing games, making friendship bracelets, winning prizes and merchandise, and sharing what they were thankful for. Each child received a pre-made meal for their family as they left.
